

## LEAs can build education workforce housing with less red tape



Research shows that one of the most cited reasons for why teachers and other school employees leave their positions is a lack of affordable housing close to the campuses where they work. This presents a significant hurdle as districts attempt to recruit and retain teachers to best support children. **"Even prior to the pandemic, we saw accelerating housing costs ... and so we've seen a lot of our educational**

**workforce moving farther and farther away, not being able to live in the communities in which they teach, and so this is where districts are really starting to look at producing education workforce housing on their own property,"** CSBA Legislative Director Chris Reeve said during a recent webinar hosted by SPUR, the San Francisco Bay Area Planning and Urban Research Association. "We're in a situation where we're facing fairly dire straits with our teacher shortage and staffing shortage across the state. Many school districts are pursuing this option — not as a matter of want, but a matter of need."

The webinar highlighted [Assembly Bill 2295](#) (Bloom, D-Santa Monica), a CSBA-sponsored bill that would remove bureaucratic hurdles and increase incentives for

**districts to develop education workforce housing on vacant school property**, which was signed by Gov. Gavin Newsom as part of a [package of housing bills](#) on Sept. 28. [Read more on the CSBA blog »](#)

## Raising awareness about scholarships



As National Scholarship Month comes to a close, new [survey results](#) from Scholaroo offer some insight into why some students don't apply. The University Index 2022 includes first-year college students' perspective on college and financial experiences. **The top reasons young students want to attend college include to maximize their earning potential, to learn, to increase their social and professional network, and to be independent**, according to the survey.

Among their biggest concerns are thinking they won't be able to pay for college. Some of most popular means of paying for college are scholarships, student loans and grants, but students seem unaware of many scholarship opportunities or think they won't win a scholarship or meet criteria. Local educational agency leaders and high school guidance offices can consider how they expand students' knowledge and confidence around scholarship opportunities. ## Have you completed your GASB report?



The Governmental Accounting Standards Board (GASB) establishes accounting reporting standards. **GASB 68 reports are required for pensions that are provided to the employees of state and local governmental employers** through pension plans that are administered through trusts. **GASB 75 reports are required for other postemployment benefits** that are

provided to the employees of state and local governmental employers. CSBA offers actuarial services through our partner DFA, LLC. **DFA, LLC provides GASB compliant reports to state and local governmental employers with no limit to the number of participants.** [Learn more »](#)
