Action requested: CSBA, coalitions urge budget conference to fund Common Core, transportation Contact your legislator to request funding for these key priorities

A coalition of statewide education organizations—CSBA, ACSA, CCSESA, PTA, Education Trust-West, Children Now and Public Advocates—collaborated on a letter to the Budget Conferees to urge them to provide another significant allocation (\$1.25 billion as approved by the Assembly) for local implementation of the Common Core State Standards (CCSS). This remains one of CSBA's key budget priorities, as we continue to hear from our members that there is significant need in order for districts and counties to provide the professional development, instructional materials and education technology that are critical to successful CCSS implementation. The Senate and Assembly included differing amounts in their respective budget proposals for this purpose. Gov. Brown did not provide an allocation in either the January budget proposal or the May Revision. The issue is now a conference item, to be resolved as part of the Proposition 98 package. Contact your legislator to urge them to support the \$1.25 billion allocation.

Senate OKs transportation funding bill SB 1137; now a budget conference item

Unanimous approval for increased reimbursement rates, COLA

The state Senate unanimously approved legislation May 29 to increase school transportation reimbursement rates for districts that are severely underfunded. CSBA co-sponsored Senate Bill 1137 by Sen. Norma Torres, which would gradually increase reimbursements for districts receiving less than 50 percent of state-approved costs. Some districts now see less than 10 percent reimbursement while others receive over 80 percent of their approved costs. The measure also provides a cost-of-living adjustment (COLA) for transportation funding for all school districts. The bill is also sponsored by the California State Employees Association and a large coalition of school transportation advocates. The Senate Budget and Fiscal Review Committee approved \$29 million for Home to School Transportation, which will be considered in the budget conference process. Contact

Legal panel discussion of teacher tenure, discipline

Recording of May 28 webcast now available on demand

If you missed the third webcast in CSBA's Education Insights: Legal Update series last Wednesday morning, you can watch the recording on our website. Moderated by CSBA General Counsel Keith Bray, the webcast featured a panel of five attorneys with a combined 115 years experience. These representatives from our five premier Business Affiliate law firms gathered to discuss Vergara v. State of California—the lawsuit filed by nine public school children and funded by the non-profit organization Students Matter—that just concluded in Los Angeles County Superior Court. Also discussed were case-related issues of tenure, layoff, discipline and the evaluation of certificated school employees. San Jose Unified School District's newly developed teacher evaluation process includes a Teacher Quality Panel comprising both teachers and administrators. Marleen Sacks, partner at Atkinson Andelson, Loya, Ruud and Romo, said that by involving teachers in the process, San Jose's process "underscores the legitimacy of the evaluation." California families go All In for affordable health insurance

Schools urged to keep spreading the word year-round

California's first open enrollment period under the Affordable Care Act helped almost 1.4 million individuals get affordable health coverage. Although open enrollment ended March 31, families that qualify for Medi-Cal can enroll year-round, and others may qualify for special enrollment in Covered California if they experience certain life changes, such as losing health insurance, a change in income, moving into the state, having a child, or gaining a dependent. Because many families do not know this fact, it is important that schools help spread the word. The All In campaign website offers informational fact sheets for a variety of audiences:

- · School leaders: Teachers, administrators, early learning and after-school programs, and other education leaders can refer to this fact sheet for suggestions on how to connect individuals to coverage.
- Parents and families: School leaders can use this fact sheet to show families the health coverage programs available now and to explain, simply, how parents and families can enroll themselves and their children in coverage.
- Spanish-speaking parents and families: This fact sheet contains the same information for parents and families in Spanish.

Common Core math examples from Khan Academy Self-paced lessons help students learn, teachers track progress

To support schools as they implement the Common Core State Standards, Khan Academy has developed thousands of new, interactive math problems. Created and reviewed by 40 math educators, the problems focus on the three components of rigor emphasized by the Common Core: conceptual understanding, procedural fluency, and real-world application. Additionally, Khan Academy has worked with the Smarter Balanced Assessment Consortium to ensure that problems are rigorous and fully aligned to every Common Core standard from K-12. CSBA's full Governing to the Core series developed to help school boards implement the standards is now available online. Issue 6, "Pathway Options for High School Mathematics," discusses the rationale for providing an integrated pathway that will prepare students for university study.

New resources to improve educational outcomes for foster youth

Federal website has guidance, clarifies requirements

The U.S. Department of Education and the Children's Bureau Administration for Children and Families have noted that, nationwide, some local educational agencies are not always coordinating educational services for foster youth with local child welfare agencies. The federal agencies are calling on schools and child welfare agencies in this May 30 letter to ensure they are complying with the Fostering Connections Act. To clarify LEAs' responsibilities and to assist state and local efforts to address the educational needs of children in foster care, the federal departments of Education and Health and Human Services have established a dedicated Web page to provide information on relevant laws, guidance and technical assistance materials.
