### CSBA iCount member survey due by June 15 *Make your voice count as a CSBA member*

The deadline to complete CSBA's iCount member survey has been extended to Monday, June 15. The extension has been offered to ensure that all CSBA members have the opportunity to complete the survey, and to ensure that the results accurately reflect the voice of governing board members and superintendents throughout California. All CSBA members received an email today, June 3, containing a link to one of two corresponding surveys — one for governing board members and one for superintendents. The survey marks the second phase of CSBA's comprehensive iCount data-gathering campaign, and it represents a key element of CSBA's long-term planning efforts. By completing the survey, you have an opportunity to exercise your voice in the association by offering valuable feedback about CSBA services and critical statewide education issues. More than 2,000 board members completed the iCount census, and it is crucial that this participation level be matched when the survey concludes. ### CSBA blog post: PE key to academic success *Former Olympian blogs about the importance of physical activity*

An estimated 40 percent of ninth-graders in California are considered overweight or obese, observes guest blogger Gary W. Hall, Jr. in a new CSBA blog post, "Physical Activity Key to Fitter, Smarter Kids." Hall, a competitive swimmer, Olympic medalist and member of Council for a Strong America's membership organization Champions for America's Future, discusses the role that physical education and activity play in both reducing the risk of obesity-related illness and in boosting academic achievement. Hall cites a study published in the Archives of Pediatric and Adolescent Medicine that found students who are physically active earn higher grades and score better on achievement tests than their inactive peers. "Because children spend the majority of their waking hours at school, teachers and administrators play a vital role in the fight against obesity by giving students more opportunities for physical activity before, during and

after the school day,” Hall says. Twenty minutes of PE each school day are not only required in California, but they can be especially critical in poor and struggling communities, where green space and playgrounds are unsafe or in short supply. [Read the Gary W. Hall, Jr. blog post.](#)
