CSBA launches radio ad, new website on reserve cap Efforts call on legislators to fix reserve cap issue

CSBA has launched a new campaign urging the Legislature to fix the cap on school district reserves. The reserve cap limits districts' ability to save for future needs and undermines local control. The campaign, produced in cooperation with the California State PTA and the League of Women Voters, features a radio ad currently running on stations around the state. [Listen to the ad](#). The campaign also includes a new website, www.repealtheccap.com. The site is devoted exclusively to providing news and information about the reserve cap issue, and includes fact sheets, press quotes and other material. It also encourages school district leaders and board members to take action by calling or emailing Gov. Jerry Brown and members of the Legislature and urging them to repeal the cap.

Gov. Jerry Brown signs vaccination bill SB 277 signing comes one day after being sent to Governor's desk

On Wednesday, June 30, Gov. Jerry Brown signed SB 277, the highly controversial and heavily scrutinized bill that eliminates California's personal beliefs exemptions for vaccinating school children. Brown signed the bill less than 24 hours after the Senate sent it to his desk on a 24-14 vote. The bill had drawn both staunch support and vehement opposition from across the state, and Gov. Brown had not offered any indication as to his likely action on the measure. In a signing message dated June 30, and addressed to the Senate, Gov. Brown states that "while it's true that no medical intervention is without risk, the evidence shows that immunization powerfully benefits and protects the community." Gov. Brown also pointed out that, after extensive debate on the issue, the Legislature did amend the bill to exempt immunization when a physician concludes that there are "circumstances, including, but not limited to, family medical history, for which the physician does not recommend immunization." Schools must promote affordable health coverage under new law

Resources in English and Spanish available to download, share

Signed into law in 2014, Assembly Bill 2706 (R. Hernández, D-West Covina), requires California public schools to add an item to student enrollment forms that provides the parent or legal guardian information about health care coverage options and enrollment assistance for school years 2015 through 2017. Beginning this year, students and families at all elementary, middle and high schools in California will receive this information and assistance. Covered California and the California Department of Education partnered with the **ALL IN Campaign** to roll out the information in the Educator Partners Toolkit. The toolkit includes: ALL IN's Customizable, one-page template in both Spanish and English with health enrollment information; California Coverage & Health Initiatives' directory of local community resources by county; and an informational flyer explaining AB 2706 to school administrators. **Visit the toolkit** to view, download and distribute these resources to teachers, administrators and families in your district's schools.
