Gov. Brown to sign CAHSEE exemption for class of 2015

SB 725 removes exit exam requirement for 2015 graduates following July cancellation

This week, Gov. Jerry Brown is expected to sign [Senate Bill 725](#) (Hancock, D-Oakland). Once the bill is signed into law, students of the class of 2015, who have met all other requirements for graduation from grade 12, will be exempt from the requirement to pass the California High School Exit Exam and can receive their high school diploma. With the passage of this legislation imminent, school district leaders should be prepared to issue diplomas to students who have met the necessary requirements for graduation in 2015, but have not passed the CAHSEE. SB 725 moved quickly through the Legislature on an urgency basis in response to the Department of Education's decision to abruptly cancel the July offering of the CAHSEE. With the cancellation of the July test, an estimated 5,000-plus graduating students statewide were left unable to meet the final graduation requirement. A separate CSBA-supported bill, SB 172 (Liu, D-La Cañada Flintridge), is also moving through the Legislature and would suspend administration of the CAHSEE through the 2017-18 school year, removing the test as a graduation requirement for students graduating in that time frame and allowing the test to be re-evaluated. SB 799, by Sen. Hill, introduced in Legislature ***CSBA-sponsored reserve cap legislation is in Assembly***

Following the public announcement at an [Aug. 18 press conference](#) on the West Steps of the Capitol, Senate Bill 799 was officially introduced to the Legislature on Thursday, Aug. 20. Authored by Sen. Jerry Hill (D-San Mateo) and co-authored by 16 bipartisan members of the Senate and Assembly, SB 799 would fix the reserve cap by reforming several key elements of the original budget trailer bill SB 858. These reforms include significantly increasing the size of the cap, clarification that it will apply only to general fund and reserve fund unassigned balances, and exempting small school districts (2,501 ADA or less). The bill was amended on Aug. 20 and is currently in the

Assembly awaiting assignment. The bill will be back to the Senate for a concurrence vote in the coming days. A new radio ad also began airing in statewide markets on Aug. 18, and editorials favoring a fix of the cap have run in outlets such as the [Sacramento Bee](#), [San Francisco Chronicle](#), [Contra Costa Times](#) and [Marin Independent Journal](#). ELA files amicus to protect districts from improper local assessments

Local assessment district had attempted to levy illegal assessment on school district

CSBA's Education Legal Alliance [filed an amicus brief](#) last week to assist Manteca Unified School District in challenging Reclamation District 17's attempt to levy an assessment on the school district. Manteca successfully challenged the assessment in Superior Court, relying on Water Code section 51200's exemption of school districts from such assessments. In its appeal, RD 17 relied on Proposition 218's restrictions on the ability of local governments to exempt other local governments from such assessments. The ELA's brief takes the position that Proposition 218 only restricts the ability of local governments and not the Legislature from exempting other local governments from assessments, which leaves Water Code section 51200 untouched. The ELA supports Manteca in this matter because this case directly impacts the roughly 70 school districts located within a reclamation district's boundaries. LCFF State Priorities Snapshot provides vital data on schools

Report includes data on achievement, engagement and climate

[The California Local Control Funding Formula State Priorities Snapshot](#) is a new online reporting tool that makes available three years of data on schools in three state priority areas: student achievement, student engagement and school climate. School board members, education stakeholders and members of the public can use the Snapshot to get information on school demographics, Advanced Placement exam results, the number of a school's suspensions and expulsions, participation in career technical education programs and other topics in an easy-to-understand format. The California Department of Education developed the Snapshot to graphically display LCFF data collected by the state and allows users to pull reports on an LEA or school as well as detailed reports that cover data at both the school and student-group level. SB 200 and AB 1101 define school district residency to include children of live-in workers

Bills limit residency investigations

Senate Bill 200 and Assembly Bill 1101, which deal with school district residency, were recently signed into law. The two bills expand residency laws to include live-in workers and limit the practices school districts can use to conduct residency investigations. SB 200 was authored by Senator Ricardo Lara (D-Bell Gardens) and requires school district residency criteria to include students whose parents or

legal guardians live three or more days per school week at their place of employment within a district's boundaries. Authored by Assembly Member Susan Bonilla (D-Concord), AB 1101 requires districts that conduct residency investigations to adopt policies that prohibit the use of surreptitious photography or video recording of students.
