The services are cost-effective, convenient, and require no exchange of cash. A ride can be ordered remotely for someone else. It is no surprise, then, that parents are turning to such services to transport their children to and from school and various extra-curricular activities. Except for specialty services aimed at transporting minors, most ridesharing services, including Uber and Lyft, have policies prohibiting drivers from transporting minors without an adult present. Nevertheless, in a ratings-driven work environment, ridesharing drivers might disregard such policies to avoid a negative rating. Aside from the convenience for parents, do these services create liability for school districts when an Uber or Lyft driver comes through the drop-off or pick-up line? What is the potential liability for school districts are aware that parents are utilizing Uber and Lyft? What steps should districts take to reduce their potential liability? 3:20 – 4:20 pm (1.0 MCLE)	Elimination of Bias: 2019 Safe and Supportive Schools Report Card: School District LGBTQ Inclusive Policies and Programs in California –The Equality California Institute launched the Safe and Supportive Schools Program in 2016 under the guidance of an advisory committee comprised of experts, teachers, school board members, school district administrators, teachers union representatives, and LGBTQ and civil rights advocates and organizations, in an effort to measure, assess, and make public the efforts of unified school districts in California to implement programs and policies that foster supportive and affirming learning environments for LGBTQ students. In Spring 2019, Equality California released its Safe and Supportive Schools Report Card providing an objective and verifiable assessment of 130 unified school districts' self-reported policies and programs related to LGBTQ youth and staff. The Report highlights some of the ways California school districts are succeeding in creating safe and supportive school environments for LGBTQ students, and sheds a light on some areas in which districts need the most improvement and require the most resources to create campus climates that are truly inclusive of all students. During this session, the presenter from Equality California will provide an overview of the national and state LGBTQ landscape, discuss relevant state laws and policies, and share key findings from the Report.
