NOTES:

- (1) Mike Gatto was sworn into office on June 10, 2010 to replace Paul Krekorian after he was elected to the Los Angeles City Council.
- (2) Bill Emmerson left the Assembly upon election to the Senate to replace John Benoit, on June 9, 2010. His total votes include votes cast in both the Assembly and Senate.
- (3) Sam Blakeslee left the Assembly upon election to the Senate to replace Abel Maldonado, on August 23, 2010. His total votes include votes cast in both the Assembly and Senate.
- (4) Senator Dave Cox had been battling prostate cancer and passed away on July 13, 2010.
- (5) Abel Maldonado left his Senate seat upon confirmation of his appointment to Lt. Governor on April 27, 2010.
- (6) Jenny Oropeza's voting opportunities were limited during this timeframe due to health reasons.
- (7) Patricia Wiggan's voting opportunities were limited during this timeframe due to health reasons.

DEFINITIONS:

VOTES FAVORABLE is any vote matching CSBA's position. For example an "AYE" vote for a bill that CSBA supports, or a "NO" vote for a bill that CSBA is opposed to or has a position of oppose unless amended on.

VOTES UNFAVORABLE is any vote not matching CSBA's position. For example an "AYE" vote on a bill that CSBA is opposed to or has a position of oppose unless amended on.

ABSENT OR ABSTAINED is either a record of absence at the time of voting or a deliberate choice not to cast an AYE or NO vote.

TOTAL VOTES is the total number of potential opportunities to cast a vote on a bill that CSBA maintains an active position on. These numbers fluctuate based on house, committee participation and floor votes. Reconsideration and suspend votes have been removed from this scoring.

% FAVORABLE TO CSBA is calculated by the total number of favorable votes divided by the total number of voting opportunities displayed in the MEASURE column.

% UNFAVORABLE TO CSBA is calculated the total number of unfavorable votes divided by the total number of voting opportunities displaying in the MEASURE column.

NOTES:

- (1) Mike Gatto was sworn into office on June 10, 2010 to replace Paul Krekorian after he was elected to the Los Angeles City Council.
- (2) Abel Maldonado left his Senate seat upon confirmation of his appointment to Lt. Governor on April 27, 2010.
- (3) Sam Blakeslee left the Assembly upon election to the Senate to replace Abel Maldonado, on August 23, 2010. His total votes include votes cast in both the Assembly and Senate.
- (4) Senator Dave Cox had been battling prostate cancer and passed away on July 13, 2010.
- (5) Bill Emmerson left the Assembly upon election to the Senate to replace John Benoit, on June 9, 2010. His total votes include votes cast in both the Assembly and Senate.
- (6) Jenny Oropeza's voting opportunities were limited during this timeframe due to health reasons.
- (7) Patricia Wiggin's voting opportunities were limited during this timeframe due to health reasons.

DEFINITIONS:

VOTES FAVORABLE is any vote matching CSBA's position. For example an "AYE" vote for a bill that CSBA supports, or a "NO" vote for a bill that CSBA is opposed to or has a position of oppose unless amended on.

VOTES UNFAVORABLE is any vote not matching CSBA's position. For example an "AYE" vote on a bill that CSBA is opposed to or has a position of oppose unless amended on.

ABSENT OR ABSTAINED is either a record of absence at the time of voting or a deliberate choice not to cast an AYE or NO vote.

TOTAL VOTES is the total number of potential opportunities to cast a vote on a bill that CSBA maintains an active position on. These numbers fluctuate based on house, committee participation and floor votes. Reconsideration and suspend votes have been removed from this scoring.

% FAVORABLE TO CSBA is calculated by the total number of favorable votes divided by the total number of voting opportunities displayed in the MEASURE column.

% UNFAVORABLE TO CSBA is calculated the total number of unfavorable votes divided by the total number of voting opportunities displaying in the MEASURE column.
