### Advertorial Guidelines

1. Headlines should not exceed more than two lines (see example layout) or 80 characters.
2. Body copy for a one page advertorial must be between 525 and 600 words. Body copy for a two page advertorial must be between 1,225 and 1,350 words. Body copy word count does not include headlines.

3. A one page advertorial should contain one landscape photograph and one company or product logo (see example layout). One-column high resolution images must be at least 4 inches wide at 300 dpi (1200 pixels wide).
4. A two page advertorial should contain one large landscape photograph and one company or product logo (see example layout). Large photographs run across the right hand page and bleed off the edge. Large high resolution images must be at least 9.25 inches wide at 300 dpi (2775 pixels wide).
5. Logos positioned at the end of the advertorial must be in vector format (Adobe Illustrator or Vector EPS files only). No QR codes. Contact information should be listed at the bottom of the advertorial to go along with logo.
6. Copy is subject to approval and editing by *California Schools* editorial staff.

### Submission

1. All copy for advertorials should be submitted in MS Word documents. Please do not format or stylize text.
2. All images/photographs may be submitted in JPG, TIFF or Photoshop format.
3. Logos must be submitted in vector format (such as Adobe Illustrator or vector EPS formats). Logos submitted as JPGs or any other pixel-based image format will not be accepted.
