Call to Action: Make sure schools are part of the Legislature's budget discussions

Register now for Board Member Action Day on May 9

The next couple of weeks in the Legislature will be critical for school boards, as decisions are now being made about the state budget and how much will be invested in LCFF, transportation and Common Core. A "rainy day" reserve for Proposition 98 and refinements to the teacher dismissal process are also under discussion. Now is the time to make legislators aware of how students in your districts and counties may be affected. So if you have not yet registered for Board Member Action Day on May 9, please do so now. Meetings will be held in your state legislator's local office. Once you are registered, CSBA's Governmental Relations team will schedule the meetings and coordinate with other school board members in your area. We will also brief you with a pre-event webinar from 10-11 a.m. Thursday, May 1. Our effectiveness as advocates for children requires a team effort, and you are a critical part of that team. ### Assembly Bill 215 poised to reach the governor CSBA will support teacher dismissal bill, with amendments

Several bills introduced over the last few years have aimed at reforming the teacher dismissal process, and CSBA remains committed to seeing that the strongest bill reaches Gov. Jerry Brown for his signature. "Our goal is not to win political victories but to achieve meaningful policy change that protects children," said CSBA President Josephine "Jo" Lucey in her April 28 op-ed in EdSource. Supported by the governor, Assembly Bill 215—introduced this year by Assembly Member Joan Buchanan, D-Alamo—is a great improvement over last year's defeated AB 375; CSBA will support the bill if it is amended to remove cumbersome evidence discovery rules, allow for extended depositions for good cause, and ensure that all sides have sufficient time to present their case, among other changes. #### Governor's rainy day proposal gets first hearing Assembly Speaker wants ACA 1 passed before budget

The governor's proposal for a strengthened rainy day fund, including creation of a separate Proposition 98 reserve, was presented to the Assembly committee in a special legislative session convened for the purpose. Assembly Speaker John A. Pérez and Gov. Jerry Brown reviewed the goals of **Assembly Constitutional Amendment1-X2** in a packed hearing late Monday. Committee members on both sides of the aisle made positive comments about the proposal in this initial overview of the legislation. On the same day as the hearing, the Legislative Analyst's Office issued **this new report** on two budget reserve proposals: the governor's ACA1-X2 and ACA 4. **Read more here** about the hearing and the LAO report.

### California graduation rate tops 80 percent National goals hinge on state improvement

More California high school students than ever are graduating on time, the latest state figures show. Better than eight in 10 students who were freshmen in 2009-10 earned a regular diploma in 2013, the California Department of Education **announced this week**. "For the first time in our state's history, more than 80 percent of our students are graduating," State Superintendent of Public Instruction Tom Torlakson said. It's the fourth straight year of improved graduation rates since the state started calculating the information through its student data tracking system. Achievement gaps persist, however: just 67.9 percent of African-American students graduated with their class in 2013, and 75.4 percent of Hispanic students. A national goal of 90 percent on-time graduation hinges on California's progress, particularly for young men of color; **read more here** about a recent national report and California dropout figures.

# Guide for school boards aims to boost student success through community partnerships Oakland, Los Angeles schools cited as models

A new guide from the National School Boards Association, along with a number of national education groups, details how school board members can work with other community partners to provide seamless services and engage community members to improve their schools. "As advocates for equity and excellence in public education, school boards play an instrumental role in addressing the pushout crisis through effective board leadership and governance," says "Partnerships, Not Pushouts: A Guide for School Board Members on Community Partnerships for Student Success." The 29-page guide encourages school boards to develop "educational models that strive to educate the whole child and involve the entire community," a goal well-aligned with California's Local Control and Accountability Plan mandate. The report examines the discipline and resource inequities that drive many students out of school, and how community schools and what the report calls "personal opportunity plans" can help students beat the odds. The Oakland Unified School District and John C. Fremont High School in South Los Angeles are called out as models.
