Comment period open on proposed changes to LCFF regulations and LCAP template

The SBE will accept written comments through July 28

On July 10 the State Board of Education voted unanimously to move ahead on the Local Control Funding Formula permanent spending regulations and the Local Control and Accountability Plan template after hearing testimony from school board members, CSBA and ASCA representatives, advocates, students, parents, and others. The proposed changes are now in a 15-day comment period, which ends on July 28. You may use this sample memo to submit written comments to the SBE by fax at (916) 319-0155; email; or by mail (see CDE notice for physical address). Following the comment period and a public meeting on July 22, the SBE will make any changes to the regulations and LCAP template and place them on its September 3-4 agenda. CSBA continues to press for reserve cap repeal Boards urged to adopt resolutions, meet with legislators by mid-August

CSBA, ACSA, CASBO and other public education management representatives continue advocacy efforts to repeal on local reserves. CSBA calls upon governing boards to adopt resolutions and meet with their legislators urging repeal of the trailer bill language that could eventually lead to school districts being required to spend their reserves and ending balances to dangerously low levels. CSBA has prepared talking points, a sample press release, and a sample **resolution** for immediate adoption. Boards are also encouraged to schedule meetings with local legislators by the middle of August. Please send a copy of your resolution and any response from legislators to Andrea Ball.

Seven California districts to support Obama's My Brother's Keeper Initiative

President Obama announced on Monday that 60 of the largest school districts will join his My Brother's Keeper initiative to improve the educational futures of young African-American and Latino boys. Collectively, the districts educate one-third or more of the nation's African-American and Latino students and nearly 40 percent of lowincome boys of color. Seven California districts will participate, including Los Angeles, Long Beach, Fresno, San Francisco, Sacramento, San Diego and Oakland. The Council of the Great City **Schools**, the primary coalition of the nation's urban schools, announced that each district will carry out 11 actions, including: improving preschool efforts to better serve African-American and Latino boys; implementing policies that increase the number of boys from these groups who graduate from high school and complete the federal form for college aid; keeping data and monitoring the progress of these boys and intervening at the earliest warning signs of problems; and reducing the proportion of African-American and Latino boys who are absent, suspended or expelled. CSBA voiced support for the My Brother's Keeper Initiative in February.
