Vergara v. State of California decision upheld, Gov. Brown appeals

CSBA issues statement on teacher tenure ruling

Gov. Jerry Brown said he will appeal a ruling by the California Superior Court that struck down protections for teachers in California. In a case followed nationally, the Court held that five laws concerning teacher tenure, dismissals and layoffs affected the quality of education for students. Gov. Brown noted in his appeal that school districts were dismissed as parties to the lawsuit for reasons that are "unclear or unexplained." State Superintendent of Public Instruction Tom Torlakson, named in the lawsuit, indicated he would ask Attorney General Kamala Harris for the appeal. California's two major teacher unions also have said they will appeal. Citing the important issues raised about inequality in education, CSBA President Josephine Lucey said in a statement issued on Friday: "We appreciate the judge's additional consideration in the final judgment issued yesterday in the Vergara v. California trial. CSBA still believes that the Vergara case is a call for all stakeholders to work together to ensure that all of California's 6 million school children have an equal opportunity to a quality education. We should not and cannot afford to wait for the appellate courts to address these critical issues. The education community should immediately begin working with the Governor and the California Legislature to resolve these important issues of inequality in education. CSBA has worked for years on these issues and remains committed to true reform by working with all of our education partners to meet the needs of our children." Read more about the appeal efforts.

Bill limiting charter school authority sent to Governor CSBA continues to support Senate Bill 1263

Senate Bill 1263, by Sen. Fran Pavley (D-Calabasas), passed the senate last Thursday by a 23-to-11 vote and is headed for Gov. Jerry Brown's desk. If signed into law, SB 1263 "would delete the authority of a charter school to locate outside the jurisdiction or geographic boundaries of the chartering school district because the charter school has attempted to locate a single site or facility to house the entire program, but a site or facility is unavailable in the area in which the

charter school chooses to locate." The bill would authorize a charter school to establish or operate a facility outside the boundaries of the school district if certain conditions are met. **CSBA issued in June a letter of support** for the bill, noting that "SB 1263 addresses the loopholes in charter law that permit charter schools to locate outside of the authorizing school district." The letter continues, "When a chartering district refuses to comply with the law, the only recourse is litigation. The hundreds of thousands of dollars spent on lawyers are better used in the classroom—serving children."

New CSBA blog post examines the language of polls

In 1943, pilot and explorer Antoine de Saint-Exupéry wrote "Words are the source of misunderstanding." In a new blog post, CSBA Policy and Programs Officer Christopher Maricle explores how the framing of words can drive misunderstanding about the Common Core State Standards. Comparing it to assumptions one makes about musical bands based on names and symbols (such as the Grateful Dead, in his case), Maricle discusses how poll questions on Common Core can shape results. He compares how the PDK/Gallup poll and Education Next poll ask their questions. As a result, both draw different conclusions, leading Maricle to make his own. "Maybe it's time to get past assumptions and arguments based on labels, and see how these new standards will contribute to student learning," he writes.
