Parcel taxes, local school bonds fare well in Nov. 4 general election

Shuffling of state senators means special elections in 2015

CSBA's colleagues at [School Services of California](#) have prepared a summary of school bond results showing that 89 out of 113 school bond measures passed on Nov. 4, 2014, representing \$9.3 billion out of \$11.6 billion on ballots throughout the state. In addition, eight parcel taxes were put forward and approved by voters. This includes an innovative [parcel tax for Oakland Unified School District](#), which will go to support high school college and career readiness programs. Elsewhere in election results, with three state senators leaving for Congress before their legislative terms are completed, we can expect special elections in 2015 to fill those seats: Senator Mark DeSaulnier of the East Bay area (SD 7); Senator Steve Knight of Antelope Valley (SD 21); and Senator Mimi Walters of Orange County (SD 37). The election merry-go-round may continue if sitting Assembly Members are elected to any of these seats.

expected to approve, this recommendation in agenda item 14 on Friday, day two of the Nov. 13-14 board meeting in Sacramento. Also on Friday, the California County Superintendents Educational Services Association will provide an update on the approval of district LCAPS and will discuss the resources and technical assistance they plan to provide local educational agencies in 2014-15. [View the CCSESA presentation.](#) Items to be discussed tomorrow, Nov. 13, include the new California Assessment of Student Performance and Progress System, an update of the History-Social Science Framework for California Public Schools, and the English-language proficiency assessments and their alignment with the state-adopted English Language Development Standards. The full [SBE agenda](#) includes 23 items. The meeting will [stream live](#) and be [archived](#) for viewing three to five days after the meeting.

California Forward releases video on LCFF Collaborative Working Group

First meeting includes discussion of best practices, challenges and opportunities

The LCFF Collaborative Working Group, dedicated to advancing implementation of California's new school funding formula, met for the first time Oct. 29 at CSBA's offices in West Sacramento. Developed by CSBA and California Forward, the coalition brings together school districts from across the state to strategize on best practices and suggest improvements to the LCFF. Anticipated outcomes of the Collaborative include developing useful research, reports and tools, with the goal of sharing the lessons learned and improving the process. The work of the Collaborative will also be incorporated in CSBA's trainings and education programs, and will inform advocacy efforts related to LCFF. The Collaborative is a three-year project and meetings are expected to be held quarterly. [Watch a new video](#), produced by California Forward, which provides a summary of the first meeting.

New SRI study examines early implementation of LCFF

Findings presented at recent PACE seminar in Sacramento

How are school districts using their new budget flexibility in the early implementation phase of the LCFF? What opportunities and challenges in the process do they foresee? What can state policymakers learn from these early experiences? Twelve independent researchers set out to answer these questions in a study conducted between June and October of 2014. Their findings are summarized in a new [research brief](#) by [SRI International](#), titled *Toward a Grand Vision: Early Implementation of California's Local Control Funding Formula*. The authors presented the findings at a Nov. 7 seminar hosted by Policy Analysis for California Education (PACE), which CSBA, ACSA, CTA and other education stakeholders attended. The brief includes data from the authors' review of LCAPs and other LCFF-related documents, plus interviews with more than 70 officials from 10 districts and 20 county offices of education, including superintendents, school board members, district staff and parents. The study concludes that stakeholders strongly support LCFF funding and are cautiously optimistic about the future of the law. Interviewees report that the LCFF has encouraged new forms of budgeting, with some districts beginning to move from a categorical mindset to a needs-based one. In addition, some districts are closely examining outcomes in order to better distribute available resources and advance learning for targeted student populations.

\$250 million available in Career Pathways Trust grants ***School districts invited to apply by Feb. 6, 2015***

In a second round of funding, school districts and community colleges are invited to apply for \$250 million in California Career Pathways Trust grants, [announced](#) State Superintendent of Public Instruction Tom Torlakson last week. The grants pay for programs that provide students with the skills, practical experience and preparation needed to succeed in college and careers. The programs not only give students “a taste of the working world before they graduate,” said Torlakson, but also “motivate and excite students, reduce the drop-out rate and increase the college attendance rate.” The grants will be available for the 2015-16 and 2016-17 fiscal years. A grant application [webinar](#) is scheduled for Wednesday, Nov. 19, from 1-4 p.m. Visit the CDE’s website for grant [application forms](#) and more information. A2A has received three major education/technology awards for being a leader in education technology services.
