Gov. Brown highlights key education issues at inauguration

Torlakson begins second term as state schools chief

"Educating the next generation is fundamental to our collective well-being," Gov. Jerry Brown said in remarks made at his inauguration Jan. 5. In his comments on education, Gov. Brown stressed the importance of helping children from low-income families and equalization of funding. In particular, he pointed to the Local Funding Control Formula as a means to address both issues. "This puts California in the forefront of educational reform," he said, noting California schools have received a funding increase of 39 percent over four years. California schools are to receive \$65.7 billion in the next year as well. Gov. Brown also acknowledged the challenges facing public education in the state: teacher training, mastery of Common Core, LCFF implementation and the affordability of state colleges and universities.

In a **statement**, **CSBA** said it "remains committed to working closely with the Governor and state leaders to ensure the successful implementation of the Local Control Funding Formula, advocating for funding adequacy for K-12 education, and eliminating laws that are the result of 'micromanagement from afar,' which hinders the ability of locally elected school leaders to oversee our public schools."

State Superintendent of Public Instruction Tom Torlakson also began his second term this month. At his swearing in ceremony, Torlakson outlined his plans, including implementing the LCFF, updating A Blueprint For Great Schools initiative, expanding career education programs that bring together high schools, community colleges and businesses, and maintaining and increasing investment in our schools.

Federal funding approved for agencies in December School districts are among the beneficiaries

HR 83, a funding and appropriations bill signed by President Obama in December, includes changes in funding for several programs central to school districts. These changes include:

- increases for Title I grants for disadvantaged students and special education grants under the Individuals with Disabilities Education Act, with up to \$25 million for each program
- increases in English Language Acquisition grants by \$14 million to help school districts accommodate unaccompanied minors
- favorable School Improvement Grants guidelines that provide more options for locally designed school turnaround programs
- flexibility for school districts under some child nutrition standards
- · level-funded grants of \$25 million for school kitchen equipment
- elimination of a decrease in funding for competitive grant programs, including Race to the Top

In other federal news, **the FCC** has approved modernizing the E-rate program. The improvements include \$1.5 billion in additional funds for broadband access and digital learning opportunities for schools and libraries. This will allow thousands of additional schools and libraries, especially in rural and remote areas, to access high-speed Internet connections. In total, E-rate funding is now just over \$3.9 billion and will help school districts with 21st century learning opportunities.

Twenty-six percent of California children live in food insecure homes

California has low participation in federal food assistance program

Kidsdata.org reports that 4.5 million Californians participated in the **CalFresh** supplemental food program, formerly known as Food Stamps. Latino and white households represented the majority of CalFresh recipients in 2014, accounting for more than 75 percent of the approximately 2 million total households receiving assistance. According to Kidsdata.org, roughly one in four children in California lives in a food insecure household. At the same time, California has the lowest rate of federal food assistance participation after Wyoming. Approximately, 57 percent of eligible children and adults participate in

CalFresh, according to U.S. Department of Agriculture research. Meanwhile, research shows that subsidized school meals that provide safety-net nutrition for children helps improve children's health and school performance.
