DOE issues final rule on compliance with IDEA's maintenance of effort

New rule takes effect July 1, 2015

The U.S. Department of Education on Tuesday, April 28, issued amendments to the regulations that govern the Assistance to States for the Education of Children with Disabilities program and the Preschool Grants for Children with Disabilities program. Both programs operate under the Individuals with Disabilities Act. The new rule requires LEAs to maintain their fiscal effort (also known as maintenance of effort) in order to meet the MOE compliance standard. In general, the rule states that school districts must be consistent each school year with regard to their MOE for special education. The rule also notes limited instances that would allow an LEA to reduce its spending while remaining compliant. A summary in Education Week includes a table from the DOE's rule, illustrating what it might look like in practice. The table "makes clear that school districts generally can only maintain or increase their spending on special education, not cut it." The new rule takes effect July 1, 2015.

State's cohort graduation rate at record high ELs experience largest percentage increase

California's cohort graduation rate climbed for the fifth consecutive year in 2014 to a record high of 80.8 percent, according to numbers **released by the CDE** last week. The number of students who began high school in 2010-11 and graduated with their class in 2014 rose 0.4 percentage points from last year. Graduation rates for other student groups also increased, with English learners experiencing the largest jump of 2.2 percentage points over prior year. The EL graduation rate is now at 65.3 percent. The Hispanic graduation rose to 76.4 — up 0.7 percentage points. However, the graduation rate for African-American students remains unchanged at 68.1 percent. **View charts**, which list graduation and dropout rates by graduating class, student subgroup and program.

New English/Spanish materials on Smarter Balanced Assessments available

SBA scores for students to go to school districts

Three new videos about Smarter Balanced Assessments are now available in the California Department of Education CAASPP Communications Toolkit in both Spanish and English. The videos center on SBA and college and career preparation. In addition, CDE is developing a guide and video for parents/guardians and teachers explaining how to read the student score reports. The guide and video will be available in June. The SBA take on an additional role this year, with the suspension of the Academic Performance Index for the 2014-15 school year. Although the API is suspended, students will still receive individual score reports, based on SBA, and local education agencies will still receive aggregate results (mean scale score and percentage of students by achievement level). CORE districts evaluate student achievement via multiple measures

10 school district collaborate to increase student success

With a mission statement that reads, "unwavering belief in equity and access for ALL students," CORE districts also believe that all of their students can achieve at high levels. CORE districts are a collaboration of 10 districts that work together to create and implement innovative strategies to increase student achievement. CORE school districts include: Clovis, Garden Grove, Long Beach, Los Angeles, Oakland, Sacramento, Santa Ana and Sanger. These 10 districts believe that assessing student achievement isn't the only way to gauge student success. Other factors, like chronic absenteeism, how students, teachers and parents view their schools, and suspension and expulsion rates are also considered. Rick Miller, the executive director of CORE, recently presented CORE's findings to the LCFF Collaborative Working group created by CSBA and California Forward. CSBA fact sheet addresses drinking water access in schools

Covers legal requirements, infrastructure, board actions

Despite the number of hours students spend on school grounds, research shows that only one in four California schools is meeting the legal requirements for drinking water access as defined by state and federal policies. A new CSBA fact sheet, **Drinking Water Access in Schools**, summarizes the health benefits of safe, adequate water consumption for students, as well as the effects that improper hydration can have on student achievement. A chart on suggested water consumption, broken down by student age range, is provided along with suggestions for promoting water consumption among students, faculty and parents. A revised wellness policy at Earlimart School District, which allows students to bring water into class, is highlighted as a best practice. The fact sheet closes with questions for school boards and recommended actions to help school districts plan for and conduct drinking water efforts in their schools.
